## 1. Introduction

Our website, <https://redyal.com> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). ## 3. What are scripts?

A script is a piece of program code that is used to make our website function properly and interactively. This code is executed on our server or on your device.

### 4.1 Technical or functional cookies

- Right to object: you may object to the processing of your data. We comply with this, unless there are justified grounds for processing.
